RESOLUTION OF THE BOARD OF DIRECTORS OF BASE VILLAGE METROPOLITAN DISTRICT NO. 1

CONCERNING PARKING RATES

WHEREAS, Base Village Metropolitan District No. 1 (the "**District**") is a quasimunicipal corporation and political subdivision of the State of Colorado, duly organized and existing pursuant to §§ 32-1-101, *et seq.*, C.R.S., as amended (the "**Special District Act**"); and

WHEREAS, pursuant to § 32-1-1001(1)(h), C.R.S., the Board of Directors of the District (the "**Board**") shall have the management, control and supervision of all the business and affairs of the District; and

WHEREAS, the District owns certain parking spaces (the "District Parking Spaces") within the Base Village Subterranean Condominium parking garage (the "Parking Garage"); and

WHEREAS, pursuant to § 32-1-1001(1)(j)(I), C.R.S., the District is authorized to fix and impose fees, rates, tolls, penalties and charges for services or facilities furnished by the District; and

WHEREAS, pursuant to § 32-1-1001(1)(m), the District is authorized to adopt rules and regulations affecting the affairs of the District; and

WHEREAS, the District duly adopted the Rules and Regulations for the Base Village Metropolitan District No. 1 on November 24, 2008, as amended (the "**Rules and Regulations**"), which set forth in Schedule B-1 ("**Schedule B-1**") the rates and charges imposed for certain uses of the Parking Garage; and

WHEREAS, the Rules and Regulations provide that the District may amend the rates and charges set forth in Schedule B-1 to the Rules and Regulation by separate resolution, without the need to amend the Rules and Regulations, and the District desires to amend the rates and charges to make them competitive with comparable rates and charges for similar facilities in the area, encourage greater use of the District facilities, and potentially increase revenue to the District; and

WHEREAS, the District finds that the parking rates, as set forth in this Resolution, are reasonably related to the overall cost of providing the facilities and services related to the District Parking Spaces; and

WHEREAS, on December 17, 2008, the Board adopted that certain Resolution of Base Village Metropolitan District No. 1 Regarding Parking and Garage Use Fees, as amended (the

"**Prior Parking Rates Resolution**"), and the Board desires to adopt this Resolution to amend, restate, and supersede the Prior Parking Rates Resolution in its entirety.

NOW, THEREFORE, be it resolved by the Board as follows:

1. <u>PARKING RATES</u>. The parking rates for the daily use of the District Parking Spaces are hereby established as set forth in the revised Schedule B-1, attached hereto and incorporated herein. The attached Schedule B-1 shall be appended to the Rules and Regulations. The parking rates set forth in Schedule B-1 attached hereto and incorporated herein shall remain in effect unless and until the same is revised or replaced by subsequent resolution of the Board.

2. <u>SEVERABILITY</u>. If any portion of this Resolution is declared by any court of competent jurisdiction to be void or unenforceable, such decision shall not affect the validity of any remaining portion of this Resolution, which shall remain in full force and effect. In addition, in lieu of such void or unenforceable provision, there shall automatically be added as part of this Resolution a provision similar in terms to such illegal, invalid or unenforceable provision so that the resulting reformed provision is legal, valid and enforceable.

3. <u>EFFECTIVE DATE</u>. This Resolution shall become effective October 6, 2023.
